Monash University Foundation Year



The Monash University Foundation Year (MUFY) is a pre-university program with proven success in preparing students for Monash University.

You'll develop your academic and English skills to the level expected of Monash students while studying subjects that prepare you for your future undergraduate course. Our supportive environment and dedicated teaching and support staff will guide you each step of the way, helping you to achieve your academic potential.

What you'll study

We have 12 subjects for you to choose from. Each subject is offered in two parts:

- Unit 1 introduces you to the subject area and key themes
- Unit 2 expands your knowledge and understanding.

To successfully complete this program, you must pass a minimum of eight different units:

- Units 1 and 2 of English (compulsory subject)
- Units 1 and 2 of at least two other complete subjects
- Units 1 and 2 of a complete subject or any two Unit 1 subjects.

Assessments

Assessments take place throughout the two semesters to provide regular feedback on how you're progressing with your learning, your strengths, and areas that need improvement. The way you are assessed may be a combination of tests, research projects, assignments, seminars, presentations and reports. Coursework makes up 100 per cent of your final mark.

Calculating your MUFY university entry score

The MUFY university entry score is an average score that is stated over 100. It's calculated by adding up the individual score obtained from all eight units and dividing that total score by eight. If you pass a ninth or 10th unit on your first attempt within two semesters, you're eligible for bonus points.

Learn digitally

MUFY adopts a learning approach which combines face-to-face instruction with self-directed learning delivered on an e-learning platform. To cope with this learning approach, you're required to have your own laptop which runs on Windows or Mac OS in English. The laptop used should also come with a built-in front-facing camera, microphone and speaker.

Students taking Fundamental Mathematics, Mathematics, or Advanced Mathematics are also required to have a graphing calculator (Texas Instruments model TI-84 PLUS CE Python edition).

AN EXCITING LEARNING EXPERIENCE

Students from more than 40 countries have chosen MUFY. As a MUFY student, you'll be immersed in a wholesome pre-university education environment, which nurtures academic excellence, self-development, leadership abilities and effective social skills.

You're highly encouraged to not just excel in your studies but to also participate in the exciting range of extracurricular activities occurring on campus all year round, such as:

- sports and talent competitions
- carnival fundraisers
- recreational and educational field trips
- financial and digital literacy workshops
- motivational workshops and camps
- community projects.

Entry requirements

Academic

Passed SPM, O-Level or equivalent with minimum five (5) credits and met Monash's English language requirement³.

Age 16 years

Australian and New Zealand Citizens

If you hold Australian or New Zealand Citizenship or Australian Permanent Residency you are not eligible to apply.

If you hold temporary resident status in Australia or permanent resident status in New Zealand you are eligible to apply for the program.

If you are granted Australian Permanent Residency after you enrol in your Foundation Year program, you may complete the program, however entry into Monash University is not guaranteed. After successfully completing your Monash College program and if you wish to apply for an undergraduate place at Monash University, you will need to apply through the Victorian Tertiary Admissions Centre (VTAC) to compete for a Commonwealth Supported Place (CSP) at Monash University.


FLEXIBILITY TO IMPROVE

You can spend just a semester retaking units to improve your overall university entry score and achieve better results⁶. There's no need to repeat the entire program, which a non-semesterised pre-university program would usually require.



SEMESTERISED STUDY MODE

You'll complete half of a subject (Unit 1) in Semester 1 before taking the second half (Unit 2) in Semester 2. This means you won't be facing the pressure of preparing for a single and final examination at the end of the program.



BROADLY STRUCTURED

A discipline-specific program such as a foundation in engineering will prepare you specifically for undergraduate studies in engineering. With MUFY, your options are unlimited. You'll have a broad pathway to any university course of your choice.



RECOGNISED WORLDWIDE

The MUFY qualification isn't just recognised by Monash – other universities in Australia, New Zealand and the UK do too. In Malaysia, branch campuses of foreign universities and private universities will also accept MUFY graduates.



SCHOLARSHIPS

As a MUFY student at Sunway College, you can apply for a range of academic and extracurricular scholarships, including the Jeffrey Cheah Entrance Scholarship which rewards high achievers in Sijil Pelajaran Malaysia (SPM), Cambridge O-Level, or Ontario Secondary School Certificate.

The Diploma of Business is your first step towards obtaining your Monash business degree. As a direct and reliable pathway into the second year of the Bachelor of Business and Commerce, this course will provide you with the skills necessary to meet the expectations Monash University has of students at an undergraduate level.

With the guidance of a dedicated team of educators, you'll learn how to work independently, think critically, and exercise academic skills while being introduced to the fundamentals of theories and practices in business such as mathematics, marketing, management, and more.

A business diploma or degree is incredibly versatile and gives you the ability to work in any industry. Whether you want to work in a multinational organisation, the non-profit sector or run your own company, you'll possess a range of transferable skills and knowledge, offering you a future of possibilities.

Course structure

Year 1

In your first year, you'll study nine units in the Diploma of Business. These subjects will provide you with a strong grounding in basic technical, theoretical, and practical knowledge that will set you on the path to a Monash business degree.

Year 2

In your second year, you'll study six core business units and two academic-skills based units that are designed to prepare you for direct transition into one of the accountancy, or non-accountancy majors of the Bachelor of Business and Commerce degree.

Prerequisites

Credit in Mathematics: Australian Year 11 equivalent.

English: Monash's minimum requirements apply. You can meet the English entry requirements with a C grade in SPM English Language and CEFR B1, B2, C1 or C2³.

The following English proficiency tests are accepted:

- IELTS (Academic)/IELTS One Skill Retake (Academic)/IELTS Online – Overall band score of 5.5 with no band less than 5.0
- TOEFL iBT/TOEFL iBT Paper Edition⁴ – A total score of 46 with 14 in Writing and Speaking, and 4 in Listening and Reading
- Pearson Test of English (Academic)⁴ – Overall score of 47 with no Communicative Skills lower than 36
- C1 Advanced/C2 Proficiency⁴ – Overall score of 162 with no skill score lower than 154

Tests must be taken within 24 months prior to course commencement.
